Subject: Declare Vehicle as Surplus Equipment

We have received the new Ford F250 pickup that was approved and ordered in December 2017. We are in the process of getting this vehicle fully equipped.

The next step in the process is to declare the replaced 2006 Ford F250 as surplus property. Once this vehicle is declared surplus, we will prepare notices for this vehicle, publish the notice in the local newspapers and post the notice at three locations in the community, advertising it for sale and requesting sealed bids with a stated minimum amount. The vehicle to be declared surplus at this time is:

- 2006 Ford F250 (098006)

Once the vehicle is declared surplus and ready for to be sold, we will establish a minimum bid amount for the vehicle. In the past the district has established the minimum bid amount as the amount mid-way between the Kelley Blue Book Trade-in Value and the Private Party Value. The bids will be brought back to the Board for final approval. However, if after a reasonable time we receive no bids for a vehicle, then a price will be negotiated for the sale of said vehicle.

Recommendation:

It is requested that the Board of Directors declare the above vehicle as surplus district property and authorize staff to proceed with the sale of the vehicle.
