Subject: Authorize New Signature Cards for Arrowhead Credit Union

Following is information about the District's accounts at Arrowhead Credit Union:

- One Checking Account and one Savings Account.
- There are six authorized signers for the accounts: All five Board Members, and Office Manager D. Jeanene Weiss. Normally there are seven signers including the General Manager/Secretary to the Board.
- Two authorized signatures are required for withdrawal of funds from the checking account, except as follows:
 - One authorized signature is required to make transfers between any District accounts at Arrowhead Credit Union.
 - One authorized signature is required to make wire transfers to the District's account with the Local Agency Investment Fund in Sacramento.

The Board needs to authorize new signature cards that remove Office Manager D. Jeanene Weiss as a signer and add General Manager/Secretary of the Board, Thomas G. Weddle. The position of Office Manager remains vacant.

WHEREAS, the Board of Directors of the Crestline Village Water District had previously authorized the establishment of accounts at Arrowhead Credit Union, and

WHEREAS, individuals holding certain District offices and positions have changed.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Crestline Village Water District as follows:

SECTION 1: That Arrowhead Credit Union, at any one or more of its offices or branches, hereby is designated as a depository for the funds of Crestline Village Water District, which may be withdrawn on checks, drafts, advices of debit, notes or other orders for the payment of monies from the District Money Market Account bearing the following appropriate number of signatures of authorized officers or employees (Agents) of Crestline Village Water District:

- Two (2) authorized signatures are required for withdrawal of funds from the accounts, except as follows:
- One (1) authorized signature is required to make transfers between any District accounts at Arrowhead Credit Union, and
- One (1) authorized signature is required to make wire transfers to the District's account with the Local Agency Investment Fund,

and that the Financial Institution shall be and is authorized to honor and pay the same whether or not they are payable to bearer or to the individual order of any Agent or Agents signing the same.

SECTION 2: There will be six authorized signers for the accounts. Those include five Board members, and the General Manager.
